Section 3: Supplemental (Non-Vacancy Specific) Recruitment Activities

- Participation in the Fisher Broadcasting Minority Scholarship Program. Fisher Broadcasting has sought to attract minority students into careers in broadcasting with annual scholarships. The scholarships have included training programs in technical areas and on-air. Applicants must be enrolled in a broadcast, marketing or journalism curriculum. Some scholarship recipients also take an internship at one of the stations, depending on their area of interest. Representing KBCI on the committee in selecting recipients was Human Resources Generalist, Amanda Kraske.
- KBCI-TV established a summer internship program for college students interested in pursuing a career in Journalist, Broadcasting, and/or Communications. The internship program allowed four students to have hands-on experience in the day-to-day functions of a News station, allowing them to acquire skills needed for their future careers.
- Every full-time opening is listed in a job bank or newsletter of a media group whose membership includes substantial participation of women and minorities.
- KBCI-TV hosted a booth in the Boise State University Job Fair on February 25, 2009. Attended by HR Generalist, Special Projects Coordinator, Administrative Assistant and Business Manager.
